### Open Discussion

- *Board member elections* will be held March 10, 2009. If you would like to run for the board, please send your resume to Patricia Ortiz so that it can be attached to the meeting invitation that will be sent to all homeowners

- at least 15 days prior to the meeting. Or, you can wait the night of the meeting and declare yourself a candidate.
- The financials and deed non-conformances were discussed and agreed to. Property liens have been filed on several homeowners who have not yet paid their 2008 maintenance fees. One property has been foreclosed on.
- TCMI is taking bids to add to the mulch in the playground area.
- TCMI will provide a cost analysis of electrical usage for HBTM for 2008.
- All repairs resulting from hurricane Ike should have now been completed. You will begin to receive notices from TCMI. If you need an extension for a legitimate reason, please contact TCMI.
- Hormoz Vassey volunteered to analyze TCMI/Tara Energy proposal for electrical service.
- The board approved purchase of three (3) tables for the pool/playground area. One is to replace a broken table; the second is to add a table to the pool area. The third will be anchored north of the pool

clubhouse area under the trees to provide a picnic area for homeowners.

- The board deferred evaluating our capital equipment replacement reserve fund to the April meeting.
- Precinct 4 Crime Statistics for RR Mud #1 were given.
- Your 2009 maintenance fees are now past due. Fifteen (15) homeowners have not paid their 2008 maintenance fees. That's 5% of the homeowners here at HBTM. Unfortunately, non-payment by these homeowners directly affects your yearly maintenance fees.

## **2009 Maintenance Fees**

Fifty-eight (58) homeowners have not yet paid their 2009 maintenance fees. Please be advised that as a homeowner you have a contractual obligation to pay these fees. You agreed to this when you purchased your home in Harvest Bend The Meadow. To avoid legal collections, contact Patricia Ortiz at TCMI to either make your payment in full or to make arrangements for a payment plan.
