Open Discussion

- Development of the Harvest Bend The Meadow website is in progress.
- The board approved to purchase two new sets of letters. (One small size and one large size) for use in our marquees.
- The financials and deed non-conformances were discussed and agreed to. Property liens have been filed on several homeowners who have not paid their 2008 maintenance fees.
- The board is evaluating our capital equipment replacement funds.
- Precinct 4 Crime Statistics for Reid Road Mud#1 were given.
- Fifteen (15) homeowners have not yet paid their 2008 maintenance fees. That is 5% of the homeowners here at HBTM. Unfortunately, non-payment by these homeowners directly affects your yearly maintenance fees.
- Hormoz Vassey has agreed to look into what it will take to form a Neighborhood Watch Committee in our subdivision. He is looking for volunteers. If interested contact Patricia Ortiz and she will forward the information to Hormoz.
- The audit for our 2007 records will be completed shortly.
- TCM is getting quotes to trim the trees in the pool area.
- Entrances to the subdivision will be decorated for Christmas at 2:00pm on Saturday November 29.
